We will stop at the Newark Valley Depot for a bathroom break and refreshments en-route to Harford where we will turn and return to Newark Valley for our lunch. This lunch is included as part of this excursion and you will have a choice of pulled pork or chicken salad. Upon getting our fill of food, we will return to Owego and anticipate setoff around 2pm to allow for your return trip home.

Due to limited seton space at both locations, this excursion will be limited to **25** participants and there will be no mentoring available. **Hyrails and large cars over "S-car" size are permitted with prior permission of the EC only**.
